2. **Disposal of Surplus Property** – Action Item – Staff requests the Directors to authorize staff to dispose of surplus property consistent with District Policy 105, Section H and Government Code 54201. Specifically referenced in the attached staff report and herein is a grouping of Survivair Self Contained Breathing Apparatus and related equipment that consist of packs, masks and tanks. Disposal of said property is referenced in the District Long Range Plan. The purchase and replacement of the equipment was completed consistent with the Long Range and General Plan obligations.
