- **3. Disposal of Property –** Action Item Staff request authorization to dispose of surplus property (Policy 105.H). (See report).
- **Mobile Computer Project** Action Item Staff request Directors to enter into a Memorandum of Understanding for "Participation and Cost Sharing" to fund the Districts share of the Mobile Computer/Mapping Project. This is a budgeted impact to the 07/08 fiscal year in Sub Object 6040 of approximately \$18,000.00.
