- **3. Policy 415 (Draft)** Information Item Staff will present a draft of a "Training Requirement Supplement Paramedic." This is a JPA contract compliance issue and is intended to align the policy of the District with contract and current practices. This is a draft only and is circulated for comment.
- 4. Adoption of Codes and Amendments First reading of Ordinance 2007-01, adopting the 2007 edition of the California Fire Code, based upon the 2006 edition of the International Fire Code, regulating and governing the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises in the Diamond Springs-El Dorado Fire Protection District; providing for the issuance of permits, collections of fees therefore; repealing Ordinance No. 2003-02 of the Diamond Springs-El Dorado Fire Protection District and all other ordinances and parts of the ordinances in conflict therewith. The Board may establish a hearing date to consider final adoption of the ordinance in December, 2007.
- 5. **Resolution 07- 05** A resolution of the Board of Directors of the Diamond Springs-El Dorado Fire Protection District defining the deadline for plans submittal and approval to the DSEDFPD.
