Public hearing to consider authorization for the annexation of the territory within the proposed Annexation No. 1 into the Diamond Springs / El Dorado Fire Protection District Community Facilities District No. 2006-01 (the "CFD) and the rate and method of apportionment of the special tax proposed to be levied on certain property within the Annexation. (American Legion

Post and Diamond Springs Villa) Ballot have been received and are unopened. Chief Cunningham read **Resolution 2008-05** and requested the board take action and approve. Motion made by Bill Flynn to accept Resolution 2008-05 as stated. Motion seconded by Robert Larsen. Roll call vote as follows:
