## **MINUTES Board Workshop for September 27, 2010**

Welcome by Thomas Keating, Fire Chief. Over 75 attendees.

### Presentation:

- El Dorado County Board of Supervisors gave fire districts a two year window to come up with a permanent funding solution.
- Chiefs can come up with ideas but only district Boards can implement them.
- Reviewed Citygate report.
- Currently Aid-To-Fire is coming out of CSA 7 funds and is about one-half of the amount previously received.
- Explanation of AB-8 procedures.
- Explanation of ERAF-I, ERAF-II, and ERAF-III.

### Two Year Plan Concept – Annexation into El Dorado Hills Water District

- Would result in the suspension of ERAFs.
- Would maintain local identity and control.
- Provides an opportunity to renegotiate AB-8 funding.
- Would have district-wide elections.

### Brian Veerkamp, Fire Chief

- Discussed AB-8, ERAF, and property tax reapportionment.

### José Henriquez, LAFCO Executive Officer

- Gave a basic explanation on how annexation into EDHWD would proceed.

### Group Question and Answer Period

- Questioned how fire districts could get a share of Proposition 172 funds. These funds are allocated by the BOS.
- Proposal has the potential for benefiting smaller districts while maintaining local identity and control.
- Concerns about liability to parent organization (EDHWD) such as OSHA violations, lawsuits, etc. EDHWD representative was very clear that they must protect their existing funding. They will not enter into any agreement that would compromise their funding or increase their liability.
