**WHEREAS**, The Board of Directors of the does hereby resolve and order as follow:

**SECTION 1**

**a.** Application and proposal is hereby made to the El Dorado County Local Agency Formation Commission for the detachment of certain property as described in Exhibit A to the Diamond Springs – El Dorado Fire Protection District, and the detachment of certain inhabited property as described in Exhibit A from the Diamond Springs – El Dorado Fire Protection District.

**b.** It is desired that the proposed detachment provide for and be made subject to the following terms and conditions:

1. Chief Todd Cunningham will be appointed as the “authorized agent for this proceeding.
2. The District request waivers for the requirements for a Service Plan and Project Information Form
3. The District contends that this project is category 20 CEQA exempt.

**c.** The reasons for this proposal are as follows:

These are tribal lands in trust for the Shingle Springs Band of Miwoks. Services historically provided by this District, without compensation, are now provided by the El Dorado County Fire Protection District (ECF). ECF provides duplicate services under a compensated contract to the Tribal Government. As a result, this District is no longer requested to provide services on a regular basis.
