- Station 48 Adhoc Committee Pettibone Based on the meeting with Grado, it does not make sense to trap a fire house inside The Crossings project. Not a good location. Mike called on another piece of property across the street it was \$249,000. Grado not interested in using the lot that Station 48 is on. Committee to look into some other properties. Contact County and see if they would be interested in the Station 48 property.

Discussed Workers Comp being over budget this fiscal year due to paying the Service Area 7 portion. Chief to reach out to FASIS. Looking for a refund. OPEB – Budgeted contribution for this year but not sure if we will pay it. Nothing in the 23-24 budget for OBEB yet. Starting a 115 Trust is also being discussed.
