Director Cooper opened the Public Hearing on the matter of establishing a First Responder Fee at 3:01 pm.

Chief Gallagher reviewed the Staff report, introduced, and waived the Second Reading of Ordinance 2023-01 establishing a first responder's fee.

Open Forum: Retired Chief Denault had a couple of questions about the Feasibility Study – He asked when it would be done and when it would be finalized. Chief Gallagher said it will not be finalized until we get the Assembly Bill regarding Classic Pension Formulas through Legislature. He had a couple of other comments on the study and will send them to Chief Gallagher. He also had a question about the District's Tax Rates. Chief Gallagher to send him a list of our Tax Rate Areas.

• October calls: E49 – 201, R49 – 3, M49 – 277. There was a total of 252 calls in the District.

OLD BUSINESS

- 1. DSP-ECF Working Group met on November 1, 2023, and discussed the CalPERS Classic Pension Formula issue. The District Attorney said that our only option to keep the Classic Formulas in place with the Annexation is to do an Assembly Bill. Staff is Working with The California Professional Fire Fighter's Association for the draft language for the Assembly Bill. Then Senator Gill will be asked to introduce and sponsor the Bill. Public outreach/messaging about the Annexation was also discussed at the Working Group Meeting. Also discussed Fleet and looking at the inventories of both districts. The group is also working on joint Board Policies and SOG's. Language regarding Retiree Health Insurance is being drafted by the attorney. The Chief will send the Draft out to retires once we receive it.
- 2. Sleepy Hollow Homeowner's Association Chief Gallagher and BC Daniels attended the Sleepy Hollow HOA's Annual Meeting. BC Daniels and the Engine Company attended their trick or treat event. We will continue to be involved and support them. Item to be removed from Agenda and discussed as needed.

Lag time between call and dispatch – info harder to get.
- Budget/Finance Standing Committee– Pettibone reported that they met last night and reviewed the profit and loss to date. Vehicle maintenance expenditures are high. Issues with E49 & E349. We budgeted \$6,000 for equipment that we haven't spent on yet. We are 1/3 of the way through the fiscal year and profit and loss is about 30% so right on track to date.
